

This document contains a summary of the responses provided to the staff questionnaires issued in May 2024.

The questions used are those asked of teachers and support staff by His Majesty's Inspectorate of Education (HMIe) prior to any school inspection visit. Separate questionnaires were issued to teaching and support staff.

On this occasion we received a total of 51 responses from teaching staff and 21 from support staff. This compares with 52 and 16 responses respectively to the surveys issued in November 2023.


We will continue to gather information twice-yearly and share a summary of these responses with our staff.

The summary of responses provided is presented both in tabular and graph form as follows:










